

## Swipe and Win Sweepstakes Official Rules

**NO PURCHASE, CHECKING ACCOUNT, DEBIT CARD, OR OBLIGATION NECESSARY TO ENTER OR WIN. NON-PURCHASE ENTRIES AND PURCHASE ENTRIES HAVE AN EQUAL CHANCE OF WINNING.**

**SPONSOR:** Idaho Central Credit Union, 4400 Central Way, Chubbuck, ID 83202.

**ELIGIBILITY:** Eligible participants must be 18 years of age or older, must be legal residents of the State of Idaho, and must possess a valid government-issued driver's license or other form of photo identification, such as a state-issued ID card or passport. Employees, volunteers and suppliers of the Sponsor, including members of their immediate family, are not eligible to participate. Immediate family shall include spouse, parents, children, siblings, grandparents and grandchildren. Sweepstakes is subject to all federal, state and local law regulations.

**TIME PERIOD:** The Sweepstakes begins at 12:00:01 AM MST on August 20, 2019 through 11:59:59 PM MST on September 30, 2019 ("Promotion Period").

- 1) **Automatic Entry:** Entry for these drawings automatically occurs every time a member of Idaho Central Credit Union makes a PIN or signature-based purchase processed through Idaho Central Credit Union during the Promotion Period with a debit card issued by Idaho Central Credit Union. In the event of a dispute as to who submitted a particular cardholder entry, such entry will be deemed to be submitted by the primary person in whose name the card used to enter the Sweepstakes was issued.
- 2) **To enter by U.S. Mail without making a purchase:** Hand-print your name, address, city, state, ZIP code, and daytime and evening telephone numbers (including area code) on a 3.5 card, and mail with postage affixed to: Idaho Central Credit Union, Attention Marketing: Swipe and Win Sweepstakes, 4400 Central Way, Chubbuck, ID 83202. Each mail-in entry will count as one (1) entry into the drawing. Mail-in entries must be postmarked between August 20, 2019 and September 30, 2019.
