### **How to enter:**

Box 2469, Pocatello, ID 83206. Only one entry per stamped envelope mailed to Idaho Central Credit Union is eligible for the contest. Entries must be received by 1/31/2024. By entering you agree to receive marketing materials from IDAHO CENTRAL CREDIT UNION. Entry form submissions are limited to one per person. All entry form fields must be completed in order to win.

### **Selection of Prize Winner:**
