

**ICCU Pasco Branch Magicycle Ocelot Pro Ebikes® Giveaway

How to Enter:

To enter the ICCU Pasco branch Magicycle Ocelot Pro Ebikes® giveaway, entrants must complete an entry form available at the Pasco branch. Only one entry per stamped envelope mailed to ICCU is eligible for the contest. Limit one entry per person. By entering you agree to receive marketing materials from ICCU. Entry form submissions are limited to one per person. All entry form fields must be completed in order to win.

Selection of Prize Winner:

Eligible participants must be 18 years of age or older, must be legal residents of the States of ID, WA, OR, or AZ and must possess a valid government-issued driver's license or other form of photo identification, such as a state-issued ID Card or passport.
